



Cases often carry a theme about the way something or someone was “before”— and how an incident(s) changed the situation. For such cases, we create slides comparing the before and after scenarios.


Explanatory Graphics

Comparisons





Acquire Basic Information


We begin by acquiring an overall understanding of the dispute and critical arguments for both plaintiffs and defendants.

THE CHALLENGE


While a more typical approach would divide the events by party, a focus on the conclusion we wanted to drive created a more persuasive presentation of the facts.


OUR IMPACT
